Licensing & Permits

- Alcohol vendors must provide a valid NYS Liquor License and applicable tasting/marketing permits.
- Food vendors must comply with all NYS Department of Health regulations and provide required permits.
- All vendors selling taxable goods must provide a valid NYS Certificate of Authority.

Insurance

All food or alcohol vendors must provide a Certificate of Insurance naming:

- Village of Speculator, 2885 Route 8, Speculator, NY 12164

Minimum coverage:

- \$1,000,000 per occurrence
- \$2,000,000 aggregate
- \$1,000,000 liquor liability (if applicable)

Sampling & Sales (Alcohol Vendors)

- Complimentary samples are required.
- All sales are for off-premises consumption only.

Set-Up & Breakdown

- Set-up begins at 9:30 AM on September 19, 2026.
- Breakdown may not begin until 4:00 PM.
- All materials must be removed by 5:30 PM.

Additional Policies

- This is a rain-or-shine event.
- Vendor fees are non-refundable and non-transferable.
- No vehicles permitted on walkways or grass outside designated areas.
- Vendors must keep booths clean and safe.
- The Festival reserves the right to accept or reject applications.
- Failure to submit required documentation may result in denial of participation.
